**Re: Open Records Request**

Dear Records Custodian:

Pursuant to the Georgia Open Records Law (O.C.G.A. §§ 50-18-70 et seq.), American Oversight makes the following request for records.

**Requested Records**

American Oversight requests that your office produce the following within three business days:

All email communications (including emails, email attachments, calendar invitations, and calendar invitation attachments) sent or received by the Pickens County officials listed below, or anyone communicating on their behalf, such as an assistant or scheduler, and containing any of the search terms listed below.

Pickens County Officials:

- a. Chairman Kris Stancil
- b. Commissioner Josh Tippens
- c. Commissioner Josh Tatum
- d. Tax Commissioner Daniel Reeves

Search Terms:

- i. GRA
- ii. "Republican Assembly"
- iii. traitor\*
- iv. accountab\*

Please note that American Oversight is using the asterisk (\*) to designate the standard use of "wildcards" in the search for responsive records. For example, a search for "traitor\*" would return all of the following: traitor, traitors, traitorous, etc. If your agency is unable to search for wildcards, please advise so that we may specifically include the variations that we would like searched.

Please note that American Oversight does not seek, and that this request specifically excludes, the initial mailing of news clips or other mass-distribution



emails. However, subsequent communications responding to or forwarding such emails are responsive to this request. For example, if Chairman Stancil received a mass-distribution news clip email containing the term “accountability,” that initial email would not be responsive to this request. However, if Chairman Stancil forwarded that email to another individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

**Please provide all responsive records from August 1, 2023 to the date the request is received.**

Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

### **Guidance Regarding the Search & Processing of Requested Records**

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages. Records of official business conducted using unofficial systems or stored outside of official files are subject to the Open Records Act.<sup>1</sup>
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.
