This letter is in response to the public records request to Duval County Public Schools, dated **February 13, 2024**. For your convenience, a copy of the original request is attached and copied below.

### You have requested:

Records sufficient to identify the number of instances in which Duval County Public Schools students have been subject to parental notification for matters of their gender, sex, gender identity, or sexual orientation under the duties outlined in either Florida House Bill 241 (HB 241) or Florida House Bill 1557 (HB 1557).

- 1) To the extent that this information is aggregated and maintained in a database or spreadsheet,<sup>2</sup> American Oversight would accept as responsive a printout from the database containing fields reflecting the date and key facts of report.

*There are no responsive records in the manner requested.*

- 2) Records sufficient to identify any potential Duval County Public Schools employee actions investigated for any potential violation of HB 241 or HB 1557 related to student gender, sex, gender identity, or sexual orientation, including, but not limited to, failure to conduct relevant parental notification.
