Comments:

After the Supreme court news broke I listened to a radio talk program with your Senate president Warren Petersen and talk show host James T Harris and appreciated the candor in which Petersen spoke including his comment " they got it right " which meant to me his agreement that abortion be completely abolished. I am in agreement with J T and did not agree when Warren twisted and said that women can choose, in the rare case of rape or incest, to kill their children. The 14th amendment states: "no person shall be denied equal protection of the law ". I believe within the spirit of the 1864 territorial law, these children are persons, now confirmed by science, as human from conception. There is no way around this senator. I would not want to be the person standing in front of God's throne someday making excuses for incrementally choosing who lives and who dies. The heartbeat and 15 week must be ended and replaced by total abortion abolition. Senator Petersen missed an opportunity in January to hear Cory Mcgar's Equal Protection bill when he wouldn't even allow its hearing. I would ask him sir, rethink your reasoning, and give it a fresh look. Equal Protection does not condemn women per se, rather it criminalizes the act of abortion, it does not establish penalties as it removes discriminatory provisions that allow abortion to continue. Either abortion is the unjust killing of a human being or isn't. If so, then all parties are responsible, including the child's own mother OR any perpetrators including the father, husband, boyfriend, sexslaver or pimp. Even parents who would force by coercion the innocent mother to abort her child. With this law we could then look for justice as they would face the penalty for murder. I ask you what justice? would prevail if abortion is not considered a murder? Equal Protection Laws would also protect mothers and their physicians from being tried in the case of a medical emergency. Miscarriages and ectopic pregnancies when unborn children die from natural causes which are altogether different from abortion. Also, does not prohibit IVF or in vitro fertilization nor does it outlaw contraception. Finally, My hope is that with the end of abortion the need for IVF may be greatly diminished with so many more babies available for adoption and the state getting out of the adoption business as it returns it to the church. Or am I seeing a view here of our Lord's return after the judgement of our nation? I'm praying for our nation and the successful ending of this travesty in our country.
