In an effort to accommodate your office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited its request to emails sent by the listed officials. To be clear, however, American Oversight still requests that complete email chains be produced, displaying both sent and received messages. This means, for example, that both a listed official’s response to an email containing a listed key term and the initial received message are responsive to this request and should be produced.

Please provide all responsive records from February 16, 2024, through the date the search is conducted.

The Oklahoma Attorney General’s Office has reviewed its records in accordance with your request and determined that the enclosed records are responsive to your request and not subject to an exemption under the Oklahoma Open Records Act. Redacted portions may relate to information privileged or exempted from the Oklahoma Open Records Act, and/or may relate to unofficial business.

It has been determined that any additional responsive documents which may exist in the possession of the Office of the Attorney General would be exempt and/or excluded from disclosure under 51 O.S.Supp.2023, § 24A.5(1)(a), 51 O.S.2021, § 24A.12, or 51 O.S.2021, § 24A.14 of the Open Records Act.

Please note, the Open Records Act exempts from disclosure records protected by a state evidentiary privilege, such as the attorney work product doctrine. 51 O.S.Supp.2023, § 24A.5(1)(a). The Open Records Act also authorizes the Attorney General to maintain litigation files as confidential. 51 O.S.2021, § 24A.12.

Attorney General Gentner Drummond is committed to transparency and our office seeks to fully comply with the Oklahoma Open Records Act. However, our office does not serve as a repository for the records of other state actors subject to the law, and is unable to search records not in our possession. It is possible that some of the records you seek may be obtained from the originating agency or other public body.
