If a request is denied in whole, please state specifically whether it is not reasonable to segregate portions of the record for release.

§ Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

- **Welcome & Disclaimer | Willard Helander**
- **Data Update | Jon Lareau**
 - **Jon Lareau:** We have to wait until data comes from the Department of Elections.
 - **Pamela Reardon:** I would think the sheer volume would be a red flag.
 - **Jon Lareau:** We can watch the voter registration list but it doesn't tell us anything about a registrants citizenship status.
 - **Pamela Reardon:** We can start running NCOA against it.
 - **Jon Lareau:** The identification of non-citizen voters has to rely on the state. It's the only data set we got.
- **Eagle AI Updates | Dr. Rick Richards**
 - We have a new facebook page and twitter feed. AZ, CO, FL, GA, NV, OH, PA, and TX with WI, MI, MD, and KY on the launchpad. We have found 1.29 million people who filled out an NCOA form and suggested they moved. We are expecting more.
 - **Willard Helander:** Could you explain how NCOA only covers 40% of people who move?
 - **Dr. Rick:** The algorithms we have written will pick up 90% of the NCOA data. Out of 1.29 million, we were able to work all but 59,000.
 - **Jon Lareau:** There has been motion in lawsuits. There have been lawsuits by PILF that have been moving some ground. There was one in ME and SC.
 - **Dr. Rick:** The next hurdle will be SC and GA.
- **Non-Citizen Voting Data | Allison Nickolai**
 - I took a unique approach to try and find information. I was really focused on the non-citizen issue. I went and work with a legislator who is also concerned about this and verified how non-citizen voters are checked. I submitted a list of checks to n
 - I got the return email address and I asked how many driver's licenses were in circulation. I was able to get the actual number of credentials in OH. They gave me the exact number of valid driver's licenses. I was hoping to use it against the voter
 - We have more non-citizens acquiring drivers licenses and if you go to the Census Bureau, you can get non-citizen data for your state. There are approximately 267,000 non-citizens in OH who are 18 and over.
 - **Jon Lareau:** You referred to the Census Data?
 - **Allison Nickolai:** The average number of registered voters is 66.9%. I'll send over information to Bryson.
 - **Willard Helander:** If people don't have an automatic contact, you might want to address that.
 - **Lester Gabriel:** When you're looking at the percentage of voters compared to the number of citizens, you'll have to account for people who have moved to other states.
 - **Allison Nickolai:** Yes, I was aware of that. OH had 85,000 moves out of state in 2022. Look Ahead America did their non-citizen challenge. They took the NCOA and matched it against the voter rolls.
 - **Lester Gabriel:** NCOA does not capture all the moves.
 - **Allison Nickolai:** There are several types of moves.
 - **Ann Grigorian:** Do you know how many have showed up out of the ones that were identified?
 - **Jon Lareau:** When you're trying to combine multiple datasets, data lag and interpolation is a big issue. The census data was collected in 2020 and they re-estimate every year but they didn't do a new census. There's a lot of organization involved
 - **Allison Nickolai:** I'm not above whatever tools are in my toolbox to get what I need. I'm a landlord. I made a phone call to job and family services. It was eye opening because I learned that they offer. They will not assist anybody who do
 - Because of HAVA and NVRA, agencies are supposed to assist in voter registration. In the forms I found a voter registration as well as a declaration of voter registration. There is a voter registration form and it clearly states on there if you
