Dear Public Records Officer(s):

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

Requested Records

American Oversight requests that the Cochise County Sheriff promptly produce the following records:

1. All email communications (including emails, complete email chains, calendar invitations, and attachments thereto) sent by Cochise County Sheriff Mark Dannels — or anyone communicating on his behalf, such as an assistant, scheduler, or secretary — and containing any of the following key terms.

In an effort to accommodate the Cochise County Sheriff’s Office and reduce the number of potentially responsive records to be processed and produced, American Oversight has limited part one of this request to emails sent by the Sheriff, or anyone communicating on his behalf, and containing any of the above key terms. However, American Oversight requests that complete email chains be produced, displaying both sent and received messages. This means that both the Sheriff’s response to an email and the initial received message are responsive to this request and should be produced.

2. All email communications (including email messages, complete email chains, calendar invitations, or any attachments thereto) between (a) Cochise County Sheriff Mark Dannels — or anyone communicating on his behalf, such as an assistant, scheduler, or secretary — and (b) anyone communicating on behalf of an external entity listed below, including, but not limited to, anyone communicating from an email address ending in a listed domain.

Please note that American Oversight does not seek, and that part two of this request specifically excludes, the initial mailing of news clips or other mass-distribution emails. However, subsequent communications forwarding such emails are responsive to this request. In other words, for example, if the Sheriff received a mass-distribution news clip email from Border 911, that initial email would not be responsive to this request. However, if the Sheriff forwarded that email to another listed individual with his own commentary, that subsequent message would be responsive to this request and should be produced.

For both parts of this request, please provide all responsive records from November 1, 2024, through the date the search is conducted.

Statement of Noncommercial Purpose

This request is made for noncommercial purposes. American Oversight seeks records regarding the operations and activities of local officials related to paramilitary activity

along the U.S.–Mexico Border.¹ Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including how local law enforcement handle issues related to paramilitary activity.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and Twitter.com.²

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying and postage charges, if applicable.³ Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
