Re: Public Records Request

Dear Public Records Officer:

Pursuant to the Arizona Public Records Law, A.R.S. §§ 39-121 et seq., American Oversight makes the following request for records.

Requested Records

American Oversight requests that your office promptly produce the following records:

1. Records sufficient to identify when the county completed initial signature verification of early ballots received on or before Election Day (November 5, 2024);
2. Records sufficient to identify how many voters were notified of the need to cure a signature during the 2024 general election cycle;
3. Records sufficient to identify how many voters were notified of the need to cure a signature post-Election Day (November 5, 2024);
4. Records sufficient to identify the method(s) used to notify voters of the need to cure a signature during the 2024 general election cycle or post-Election Day;
5. Records sufficient to identify the last day notices to cure a signature were sent, how many such notices were sent, and by what means or methods;
6. Records sufficient to identify how many ballots had not been signature verified by 5:00 PM on November 10, 2024; and
7. Records sufficient to identify how many ballots that had been sent notices to cure and had not been signature verified by 5:00 PM on November 10, 2024.

Please provide all responsive records from October 9, 2024, through November 25, 2024.



Statement of Noncommercial Purpose

This request is made for noncommercial purposes. American Oversight seeks records regarding ballot signature curing efforts. Records with the potential to shed light on this matter would contribute significantly to public understanding of operations of the government, including how and when ballot signatures were cured as part of the November 2024 election.

Because American Oversight is a 501(c)(3) nonprofit, this request is not in American Oversight's financial interest and is not made for a commercial purpose. American Oversight's mission is to promote transparency in government, to educate the public about government activities, and to ensure the accountability of government officials. American Oversight uses the information gathered, and its analysis of it, to educate the public through reports, press releases, or other media. American Oversight also makes materials it gathers available on its public website and promotes their availability on social media platforms, such as Facebook and X (formerly Twitter).¹

Because this request is made for noncommercial purposes, American Oversight requests that any fees charged in connection with processing this request be limited to copying and postage charges, if applicable.² Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fees.

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.

- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.
