This is in response to your Freedom of Information Act (FOIA) request made on January 30, 2025, to the U.S. Office of Personnel Management (OPM) Office of the Inspector General (OIG) seeking the following:

“All records reflecting communications (including emails, email attachments, text messages, messages on messaging platforms (such as Signal, Slack, GChat or Google Hangouts, Lync, Skype, or WhatsApp), telephone call logs, calendar invitations, calendar entries, meeting notices, meeting agendas, informational material, draft legislation, talking points, any handwritten or electronic notes taken during any oral communications, summaries of any oral communications, or other materials) between (a) Inspector General Krista Boyd, or anyone communicating on their behalf, and (b) the external individuals and entities listed below:

1. President-elect Donald Trump and/or anyone communicating on his behalf and/or on behalf of Donald J. Trump for President 2024 and/or Trump Save America Joint Fundraising Committee (donaldjtrump.com, trump.com, trumphotels.com, donaldtrump.com, and/or 45office.com)
2. Vice President-elect JD Vance
3. Anyone communicating on behalf of the Trump Vance 2025 Transition Team (transition47.com, trumpvancetransition.com, dtjtfp24.com)
4. Anyone communicating on behalf of the Trump Vance Inaugural Committee (t47inaugural.com)
5. Anyone communicating on behalf of the Presidential Transition Team (ptt.gov)
6. Elon Musk, Vivek Ramaswamy, Bill McGinley, and/ or anyone communicating on behalf of the Department of Government Efficiency (DOGE)

Please provide all responsive records from November 6, 2024, through January 20, 2025.”

Your request was processed, and a search was conducted under FOIA, 5 U.S.C. § 552(a) by OPM OIG. After conducting a search, no records responsive to your request were located.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of FOIA. *See* 5 U.S.C. § 552(c). This response is limited to those records that are subject to the requirements of FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
