Re: Kansas Open Records Act Request

Dear Records Custodian:

Pursuant to the Kansas Open Records Act (KORA), Kan. Stat. § 45-215 et seq., American Oversight makes the following request for records.

Requested Records

American Oversight requests that the Chase County Sheriff's Office produce the following records within three business days:

1. Records sufficient to identify the number of people detained by Immigration and Customs Enforcement (ICE) in the custody of the Chase County Sheriff's Office that have sought medical treatment or care.
2. Records sufficient to identify the number of complaints, whether official or unofficial, submitted to the relevant offices in your agency by anyone detained by ICE in the custody of the Chase County Sheriff's Office regarding Chase County Jail facility standards or conditions.

To the extent that your agency maintains aggregated information, such as spreadsheets or database records that can be readily exported to spreadsheets, such documents would be responsive to this request.

3. All complaints and/or dissent memoranda, including, but not limited to grievance or ethics complaints, submitted by anyone detained by ICE in the custody of the Chase County Sheriff's Office regarding Chase County facility standards or conditions.

To be clear, American Oversight is **not** asking your agency to release the names of any individuals or offenders who have submitted responsive documents and does not object to withholding the name of any individual expressing consent.

For all parts of this request, please provide all responsive records from January 1, 2024, through the date the search is conducted.



Please notify American Oversight of any anticipated fees or costs in excess of \$100 prior to incurring such costs or fee.

If your office is not the custodian of the requested records, please notify American Oversight and furnish the name and location of the appropriate custodian, pursuant to Kan. Stat. § 45-218(d).

Guidance Regarding the Search & Processing of Requested Records

In connection with its request for records, American Oversight provides the following guidance regarding the scope of the records sought and the search and processing of records:

- Please search all locations and systems likely to have responsive records, regardless of format, medium, or physical characteristics.
- In conducting your search, please understand the terms “record,” “document,” and “information” in their broadest sense, to include any written, typed, recorded, graphic, printed, or audio material of any kind.
- Our request for records includes any attachments to those records or other materials enclosed with those records when they were previously transmitted. To the extent that an email is responsive to our request, our request includes all prior messages sent or received in that email chain, as well as any attachments to the email.
- Please search all relevant records or systems containing records regarding agency business. Do not exclude records regarding agency business contained in files, email accounts, or devices in the personal custody of your officials, such as personal email accounts or text messages.
- In the event some portions of the requested records are properly exempt from disclosure, please disclose any reasonably segregable non-exempt portions of the requested records. If a request is denied in whole, please state specifically why it is not reasonable to segregate portions of the record for release.
- Please take appropriate steps to ensure that records responsive to this request are not deleted by the agency before the completion of processing for this request. If records potentially responsive to this request are likely to be located on systems where they are subject to potential deletion, including on a scheduled basis, please take steps to prevent that deletion, including, as appropriate, by instituting a litigation hold on those records.

If you have any questions regarding how to construe this request for records or believe that further discussions regarding search and processing would facilitate a more efficient production of records of interest to American Oversight, please do not hesitate to contact American Oversight to discuss this request. American Oversight welcomes

an opportunity to discuss its request with you before you undertake your search or incur search or duplication costs. By working together at the outset, American Oversight and your agency can decrease the likelihood of costly and time-consuming litigation in the future.

Where possible, please provide responsive material in an electronic format by email. Alternatively, please provide responsive material in native format or in PDF format on a USB drive. Please send any responsive material being sent by mail to American Oversight, 1030 15th Street NW, Suite B255, Washington, DC 20005. If it will accelerate release of responsive records to American Oversight, please also provide responsive material on a rolling basis.

Conclusion
